## **EXERCISE OF OPTIONS**

Rex Minerals Ltd ("Rex") wishes to advise that 160,000 options have been exercised today. Options exercised include 100,000 options at an exercise price of \$0.102 expiring 30 June 2011 and 60,000 at an exercise price of \$0.552 expiring 31/05/2012. An Appendix 3B follows accordingly.
