## PLACEMENT SHARE ISSUE AND APPENDIX 2A

This notice is given by Rex Minerals Ltd (Rex or the Company) under section 708A(5)(e) of the *Corporations Act 2001* (Cth) (Corporations Act).

Following the announcement of the successful completion of its Placement on Friday, 16 April 2021, Rex has today issued 39,583,334 fully paid ordinary shares at an issue price of A\$0.24 per share to raise A\$9.5 million before costs.

The issue of ordinary shares has been made without disclosure to investors under the fundraising provisions of Part 6D.2 of the *Corporations Act 2001* and this notice is being given pursuant to section 708A(5)(e) of the Corporations Act. As at the date of this notice, the Company has complied with its financial reporting and auditing obligations under Chapter 2M of the Corporations Act and its continuous disclosure obligations under section 674 of the Corporations Act.
