## **Placement Share Issue – Tranche 2**

Following announcements on 19 October and 13 October 2010, Rex Minerals Ltd (“Rex”) is pleased to confirm the successful completion its \$85 million capital raising. Following approval of shareholders at the Rex AGM held on 25 November 2010 for Tranche 2 of the capital raising and the receipt of \$42.5 million, Rex advises that 17,000,000 fully paid ordinary shares have been issued today at an issue price of \$2.50.
